### **Euro Medium Term Note Programme**

This Supplement (the "Supplement") is supplemental to, forms part of and must be read and construed in conjunction with, the base prospectus dated 22 March 2017 (the "Base Prospectus") prepared by Banco de Sabadell, S.A. (the "Issuer") and its supplements dated 28 April 2017 and 08 August 2017 in connection with its Euro Medium Term Note Programme (the "Programme") for the issuance of up to Euro 5,000,000,000 in aggregate principal amount of notes (the "Notes"). This Supplement constitutes a supplement to the Base Prospectus for the purposes of Article 16 of Directive 2003/71/EC. Terms given a defined meaning in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement.

This Supplement has been approved by the Central Bank of Ireland (the "CBI") in its capacity as competent authority under Directive 2003/71/EC, as amended (the "Prospectus Directive"). The CBI only approves this Supplement as meeting the requirements imposed under Irish and European law pursuant to the Prospectus Directive.
